

Challenges

Supreme Court's decisions in Central Organisation for Railway Electrification v M/s ECI SPIC SMO MCML (JV) and Perkins Eastman v HSCC India, prohibit unilateral appointment of arbitrators and mandates equal treatment of parties at all stages of the arbitration process.
